Privacy and cookie policy of the International Billiard Promotion Foundation (IBPF) according to the new privacy law GDPR.

We respect your privacy. IBPF strives to safeguard your privacy to the best of its ability and will ensure the confidentiality of the information you provide to us. We process personal data in compliance with applicable privacy laws and regulations. In this privacy and cookie policy, we explain the way in which we handle your data.

Categories of personal data

By using the website and the services available on it, you transmit certain data to us. This also happens at our tournaments and events. This may include personal data. We only store and use the personal data that are directly provided by you or of data that, at the time of submission, are clearly intended for processing by us. Depending on the service you use, we may collect the following information:

- Name and address;
- Sex;
- E-mail address;
- Telephone number;
- Payment details;

Basis for data processing

We may only process your personal data lawfully if we have a legal basis to do so. We process your personal data because this is necessary for the registration, participation, and conclusion of our events as specified in article 6, paragraph 1, section b of the General Data Protection Regulation (GDPR). In addition, we may process your personal data for another legitimate interest, such as informing our participants of current affairs, tournament information, and other relevant event and/or activities. This basis is specified in article 6, paragraph 1, section f of the GDPR.

Data processing purposes

The personal data collected by us will be used for the following purposes:

- Creating your account to sign up for the events;
- Logging into your account;
- Keeping track of your results;
- Planning competitions;
- Placing an order in the online store;
- Presenting live scores;
- Sending a newsletter;
- Improving the services that we provide;
- Implementing other services requested by you.

Provision of your personal data to third parties

In principle, we only provide your personal data to third parties that have a contractual agreement with us. By registering and participating in our events, you consent, in principle, that your personal data may be forwarded to a third party (affiliated to our branch of sport and organization).

Retention period

In principle, your data are part of the history of our events and as such are always kept unless you explicitly request in writing to erase these data. The erasure of this data, which is important for the history of our events, means that you can no longer participate in our events and is therefore final.

Digital storage

We store your personal data digitally to ensure that our events are presented professionally. We process your data in accordance with our privacy and data security policy. You agree to this storage, which includes processing, by registering for our events.

This is how we handle your personal data:

- We store and use your personal data so that events are presented professionally and that applications are processed smoothly.
- We only transfer your data to third parties if this is necessary for the events that you are involved in as a participant. If specific permission for this is required by law, we will ask you for it in advance.
- You can view your personal data via the players profile. You can have this information switched off or blocked for third-party access at your request. To do so, you will have to submit a written request.
- If you believe that the personal data we have stored about you is incorrect, you may ask us in writing to rectify your personal data.
- You can ask us to erase your personal data. If we do this, you can no longer participate in our events.
- You may withdraw your consent for our processing of your personal data. We will do so within 14 days of your request. After your personal data have been erased, you can no longer participate in our events. (See above.)
- You can also object to the manner in which we process your data.
- We will notify you if anything has gone wrong with your personal data.

Security measures

In order to protect your data as effectively as possible, we have taken appropriate security measures:
our partner who manages our server has issued an approved security certificate that can be requested at any time.
